BITCHES IN SEASON will be permitted to run.

ALL DOGS PRESENT MUST BE HELD ON LEASH or otherwise restricted except when in the exercise ring. Under no circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. See Chapter 1, Section 20 of the AKC Herding Regulations.

EXPRESS ENTRIES – If you send your entries via any type of express mail you **MUST** waive recipient signature. If not, there is no guarantee that your entry will be picked up in a timely manner.

Trial location will be available from 7:00 am to 6:00 pm or one hour after conclusion of Trial.

Owners or their Agents are solely responsible for the presence of their dog(s) at the Test/Trial arena. Judges are not required to wait for dogs.

Exhibitors are expected to maintain the premises in a clean, tidy condition and to pick up after their dogs.
